## Internal Compliance Committee

The Internal Complaints Committee (ICC) is an obligation under the Act which must be adhered to by an employer of a workplace with more than ten employees as per Section 4 of the Act. The Act was enacted after the decision of the Supreme Court in the case of Vishaka and Others v. State of Rajasthan and Others (1997 (7) SCC 323), where the honorable court laid down guidelines relating to sexual harassment of women at the workplace, known as "Vishakha Guidelines".

The Sexual Harassment of Women under the Workplace (Prevention, Prohibition and Redressal) Act was enacted in the year 2013 with threefold purposes:

1. Providing protection to women against sexual harassment at the workplace,
2. To prevent sexual harassment
3. To provide a Redressal mechanism for complaints relating to sexual harassment at the workplace
